December 15, 2014 Preliminary Budget Presentation - General Fund Revenues and Expenditures

January

January 12, 2015 Preliminary Budget Presentation
January 20, 2015 Public Budget Presentation – Valley View Elementary
January 26, 2015 Board of School Directors makes available proposed preliminary budget (PDE 2028) for public inspection or adopts a resolution to not raise taxes above the index
January 28, 2015 Public Budget Presentation – Valley View Elementary – Make-up Date for January 20th

February

February 3, 2015 Board of School Directors submits data on proposed tax increase along with resolution
February 9, 2015 Preliminary Budget Presentation - Board of School Directors publishes notice of intent to adopt preliminary budget if a resolution was not adopted
February 13, 2015 PDE notifies District regarding whether tax rates are equal to or exceed the index
February 18, 2015 Board must adopt preliminary proposed budget and approve applying for exceptions from PDE. (Unless resolution is adopted)
February 23, 2015 Board of School Directors to submit tax increase information to PDE on tax increases (PDE 2028)
February 26, 2015 Board of School Directors must publish notice of intent to file for exceptions (Unless resolution adopted)

March

March 5, 2015 Board of School Directors request approval of exemptions from PDE
 March 20, 2015 Referendum question to election official if district is seeking voter approval of a tax Increase (Unless resolution is adopted)
 March 25, 2015 PDE must rule on District's exceptions
 March 30, 2015 Board of School Directors submits denied exceptions to election officials

April

April 6, 2015 Proposed Final Budget Presentation (Update)
 April 13, 2015 Proposed Final Budget Presentation (Update)

May

May 1, 2015 County Assessors' office provides District with certified homestead/farmstead report
 May 4, 2015 Proposed Final Budget Presentation
 May 7, 2015 Public notice of intent to adopt the Final Budget no later than 10 days prior to adoption
May 18, 2015 Final Budget adoption
 May 19, 2015 Primary Election

June

June 2, 2015 Board of School Directors adopts proposed final budget and mails Certification of Use from PDE-2018 to PDE
 June 30, 2015 Board of School Directors must adopt final budget by this date according to regulations

- ***Should the Commonwealth of PA adopt the state budget after June 30 in which there is a provision that the District can reopen the budget, the Board of School Directors shall reopen the budget and update the budget to conform with the appropriation in the State budget.***
